2020 AHIP Certification for MAPD Sales

Jump-start your preparation to sell Blue Shield's MAPD and PDP plans for 2020 with AHIP certification training, which starts June 17, 2019. We'll reimburse you **up to \$100** when you **enroll five new Blue Shield MAPD members** for the 2020 plan year.*

AHIP training is required for brokers annually before they can receive commissions for new sales and renewals for MAPD and PDPD clients.

Our 2020 AHIP certification training launch means the 2019 AHIP training will no longer be available. However, the 2020 certification allows you to take both the current year and 2020 product-specific training, which goes live in early August.

Don't forget: You're required to pass both the AHIP certification and Blue Shield's 2020 product-specific training to be qualified to sell.

If you use our [AHIP certification site](#), we'll reimburse you up to \$100 of the \$125 AHIP certification fee when you enroll **five new** Blue Shield MAPD members for the 2020 plan year.*

* You must complete training on AHIP's site through Blue Shield's registration page to be eligible for reimbursement. Download the [reimbursement request form](#) available on Broker Connection. All five MAPD members must be active for at least 60 days prior to your
